Generators

Dumping at lagoon

Potholes

Maintenance Supervisor Hauptli has had numerous complaints about the potholes and requested permission to purchase asphalt to fill them at 104 per ton. Council Member Jackson made a motion to approve purchase of asphalt, second by Council Member Wilcoxon.
