Complaints have been made to Town Marshal Foust for the constant speeding that happens on West Street. Discussion was had on how to remedy the problem. No motion was carried.

Maintenance:

Tires for Chevy 2500

Council Member Wilcoxon made a motion to approve purchase new set of tires for the town maintenance truck, in the amount of **\$811.93** from Ricks Service, second Council Member Jackson.

Motion was carried with a vote of 3 yes 0 no.

Public comment:

There was questioning about public comment vs requesting to be put on the agenda would the time limit be different for each case. Council stated only public comment was limited.

Gene Payne-County officers is it completely up to them to police these ordinances? Concerns were brought up about how to properly get some of the ordinance violations resolved with the help of the county and town officials working together.

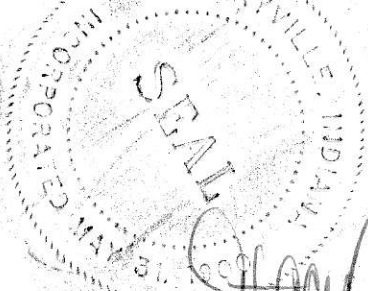
There are tires in yards that will breed mosquitos and rats running out of properties; are those health concerns?
