AMENDING ORDINANCE NO. 2012-03-01 ENTITLED “AN ORDINANCE REGARDING OPERATING & USE OF GOLF CARTS IN MEDARYVILLE, INDIANA” TO ADD PROVISIONS TO REQUIRE THAT GOLF CARTS BE ANNUALLY REGISTERED WITH THE TOWN, ESTABLISH A REGISTRATION FEE, AND CREATE A GOLF CART PERMIT FEE FUND

WHEREAS, on or about March 2012, the Medaryville Town Council enacted Ordinance No. 2012-03-01 entitled “*An Ordinance Regarding Operating & Use of Golf Carts in Medaryville, Indiana,*” which allowed for the operation of golf carts within Town limits; and

WHEREAS, the need exists to require owners of golf carts, who intend to operate the same on streets, roads, or public right-of-ways in the Town, to register their golf cart with the Town.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Medaryville, Indiana that Ordinance No. 2012-03-01 is hereby amended to add Sec. 7 and Sec. 8 as follows:

Sec. 7: Registration; Registration Fee; and Reciprocity.

- a. Prior to the operation on any street, road, or public right-of-way in Town, a golf cart shall be registered by its owner with the Medaryville Police Department. Upon such registration, the Medaryville Police Department shall issue two numerical identification decals to the owner and shall maintain a record of each identification number, along with the name and address of the registered owner. The identification decals shall be affixed to the front and rear fender areas of the cart so as to be fully visible when the cart is in operation. In addition, at the time of registration, the Medaryville Police Department should review all terms and conditions of the use of golf cart within Town limits with the registered owner as outlined in Ordinance No. 2012-03-01.
- b. A registration fee of Twenty-Five Dollars (\$25.00) shall be payable at the time of registration, and the registration shall be effective for a period of one (1) year. All registration fees for golf carts are to be deposited in the Golf Cart Permit Fee Fund.
- c. Only for purposes of attending special events in Town, out-of-Town guests may operate their golf cart in Town for the special event so long as their golf cart is registered with the municipality in which the guest resides. If their golf cart is not registered with the municipality in which the guest resides, guests must register their golf cart with the Town as outlined in subsection (a) and (b) above.


Sec. 8: Golf Cart Permit Fee Fund.

There is hereby created a non-reverting Golf Cart Permit Fee Fund. The purpose of the Fund is for receipt and distribution of funds received from golf cart registrations. Said Fund can only be


used for the purchase of decals by the Town for golf carts, training for law enforcement, or the purchase of equipment for law enforcement. If this Fund should be terminated in the future, the proceeds in this Fund shall be placed in the Town's General Fund.

This Ordinance shall take effect after the same has been passed by the Town Council, any necessary publication, and pursuant to I.C. 9-21-1-3(b) when signs giving notice of the local traffic regulations for golf carts are posted upon or at the entrances to the public highways, streets, and alleys.


Passed by the Town Council of the Medaryville, Indiana, this 17 day of June, 2021 by a vote of 3 yes to 0 no.


